OFFICE ORDER No.- 02

With Reference to RFE {PR No. 284034 Agriculture (22-23):D} floated by Organic Farming Authority of Jharkhand (OFAJ) dated on 10.12.2022 invited bids through online mode for supply of organic farm inputs in Jharkhand state.

Whereas pursuant to the evaluation of various bids & after subsequently upon verification it was found that bid documents submitted by M/s Advance Crop Care (India) Pvt Ltd, Reg office- 203, Indore Trade Center, South Tukoganj, Indore-452001, Madhya Pradesh was not genuine & in fact forged & fabricated. Proceeding of evaluation report of Advance Crop care (India) Pvt Ltd has also uploaded on public domain of OFAJ portal.

And Whereas, in terms of RFE documents read with the applicable law, the OFAJ is empowered to seek further action against the M/s Advance Crop Care (India) Pvt Ltd for having indulged in such fraudulent act. In this regard RFE Clause "O" (viii) may also be referred which is read as under:

Clause "O" (viii) FRAUD AND CORRUPT PRACTICES:

The Chief Executive officer, "Organic farming Authority of Jharkhand", requires all the Bidders should observe the highest standard of ethics.

In pursuant to this policy, following has been defined. "Corrupt Practice" means behaviour on the part of officials in the public or private sector by which they improperly and unlawfully enrich themselves and or those close to them, or induce others to do so, by misusing the position in which they are placed, and includes the offering, giving, receiving or soliciting of anything of value. "Fraudulent Practice" means a misrepresentation of facts in order to influence an evaluation process of execution to the detriment of the Government and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid price at artificial non-competitive level.

In such an event the Chief Executive officer, "Organic farming Authority of Jharkhand", shall forfeit the EMD and debar or blacklist the BIDDER from participating in future bidding processes of the OFAJ Jharkhand for a period of 1 to 5 years.


And Whereas in the premises, a case is made out against the bidder M/s Advance Crop Care (India) Pvt. Ltd for blacklisting on account of having indulged in such fraudulent act.

And as the Chief Executive Officer of Organic Farming Authority of Jharkhand (OFAJ) has also received a written instruction from agriculture department (letter no. 03/कृसाओ-

20/2022-1274 दिनांक 19.05.23) to blacklist those agencies which has submitted forged & fabricated documents in tender & take a legal action against them.

The Chief Executive Officer of Organic Farming Authority of Jharkhand (OFAJ) has considered all the facts and is of the view of that the bidder M/s Advance Crop Care (India) Pvt. Ltd is hereby Blacklisted for 5 years from taking part in future bidding process of OFAJ projects.
