FINAL PROCEEDING FOR EMPANELMENT OF SERVICE PROVIDERS

With Reference to EOI {PR No. 219812(Agri)19-20D} for service provider's for implementation of organic certification program for horticultural or agricultural produce in Jharkhand has evaluated by technical committee members on 27th Dec 2019 and evaluation report has uploaded of web portal of OFAJ on 1st Jan 2020 where we have asked from the bidder to submit their grievances or objection on this evaluation report within 7 days if any.

One agency Sheel biotech Ltd has submitted their grievances on 3rd Jan 2020 on following points

Section C

i. Registration Act :-

Remark:- While Re-evaluation of bidder's documents technical committee members has found the justification which bidder has given are not correct. Bidder has claim that his organization is a firm but in EOI, it's clearly mention about firms registration act. If word "Act" is there that means certain statutory law should be exist.

Firms Registration Act comes under Indian Partnership Act 1932 while bidder has registered under Companies Registration Act 1956 which is different.

Firms registration act and companies registration act has different legal identity. Firms registered under Registrar of Firms (RoF) while companies registered under Registrar of Companies (RoC)

So whatever technical committee members has evaluated earlier that was found correct.

ii. GST Registration Certificate:-

Remark:- While Re-evaluation of bidder's documents technical committee members has found the justification which bidder has given are not correct. Still main page of certificate of registration (GST) are not observed and only annexure of GST has enclosed. So whatever our technical committee members has observed earlier that decision was correct.

Moreover OFAJ has not rejected bidder's application on this clause.

iii. Affidavit:-

Remark :- While Re-evaluation of bidder's documents technical committee members has found that the justification which bidder has given are not correct. As per EOI, Refer minimum eligibility criteria (point no. 8) where we have clearly mention that "Bidder shall submit an affidavit on Rs 100 non judicial stamp from Notary that "the company has **never been blacklisted or terminated earlier** by any state or union government."

While Draft Version of Bidder's affidavit are :- "The Sheel Biotech Limited is **presently** not blacklisted /deregistered / debarred by any state or union government as on date and are not affiliated with any political /religion / government endowment.

There are difference in word version which bidder has submitted as compared to EOI version where no any clarity on declaration are reflecting for any past period and so whatever our technical committee members has evaluated earlier that was found correct.

iv. Experience in Marketing of organic produce :-

Remark :- While Re-evaluation of bidder's documents technical committee members has found that bidder has not submitted any transaction certificates in support of claim

for marketing of organic produce as mention in EOI and whatever technical committee members has mention earlier in evaluation report that was found correct.

v. Audited Balance sheet:-

Remark:- Technical Committee members are not agree with bidder's claim where bidder has mention that OFAJ had desired last three years balance sheet (2015-16, 2016-17 & 2017-18)

Refer minimum eligibility criteria (Point no. 7) of EOI, where we have clearly mention that bidder has to submit audited balance sheet for F.Y 2016-17, 2017-18, & 2018-19)

So after re-evaluation of bidder's documents technical committee members has found that balance sheet for F.Y 2018-19 are missing and whatever technical committee members has mention earlier in evaluation report that was found correct.

vi. ITR for A.Y 2019-20

Remark:- Technical Committee members are not agree with bidder's claim where bidder has mention that OFAJ had desired ITR of Last three years and bidder has submitted it for A.Y 2015-16, 2016-17 & 2017-18 accordingly.

Refer minimum eligibility criteria (Point no. 7) of EOI, where we have clearly mention that bidder has to submit audited balance sheet & IT Return for last three financial years (F.Y 2016-17, 2017-18 & 2018-19)

IT-Return for Financial Year 2018-19 should be technically accepted for A.Y 2019 -20 and ITR for A.Y 2019-20 has not submitted by the bidder. So whatever our technical committee members has observed earlier that was found correct.

Moreover OFAJ has not rejected bidder's application on this clause.

vii. Earlier Experience in organic farming in Jharkhand

Remark:- Bidder has already accepted that they don't have any earlier experience in organic farming projects in jharkhand.


Remark :- OFAJ has not rejected bidder's application on this clause



These five selected agencies are:-


